<b>Key Findings of the Survey (Regional):</b>									
<b>Quebec leads the country in water concerns:</b>									
More Quebec respondents believe their tax dollars should be spent on water first (8.3%) in comparison to any other region (7.2% British Columbia, 5.8% Ontario, 4.8% prairies)									
16.8% of Quebec respondents think their water operation industry is undervalued against other utilities, followed by 15.8% in Ontario, 15.1% in the Prairies and 14.5% in BC .									
<b>Atlantic Canadians secure water first in an emergency:</b>									
More than any other province/region, a majority of Canadians in Atlantic Canada (69.7%) think water is the most important item when prepping for a natural disaster									
<b>Ontarians are most concerned with handsome homes:</b>									
22.1% of Ontario respondents would rather scope out their new neighbours or the finishes in a new home (19.1%) than check the water/water pressure (4.0%) in the potential home.									
<b>The Prairies don't covet careers in water:</b>									
Canadians living in the prairies had the least desire (4.5%) to become a water operator when they grow up compared to other Canadian regions.
